Fall Green Waste Collection - December 13



The City of Albuquerque's Solid Waste Management Department will pick up residential Green Waste at no additional charge. All Green Waste must be placed 5 feet from automated trash and recycling containers as well as any large items scheduled for pick-up. Solid Waste customers must place their Green Waste (leaves, grass, and brush) in trash bags. Each trash bag should not weigh more than 40 pounds. Customers that have branches must cut them to four-foot lengths and bundle them securely. The following items will not be picked up: dirt, construction debris, gravel, construction material or tree stumps.
